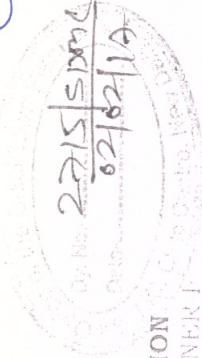

**C I R C U L A R**

**Subject :** Colour Coded Zonal Maps (CCZMs) of the Departments from where NOC is required.

Under Ease of Doing Business, the process of sanction of building plan is being monitored by the Ministry of Urban Development, Govt. of India, Department of Industry & Promotion, Govt. of India. In the series of meeting held in the Ministry of Urban Development, it was directed that outside the influence area given in Colour Coded Zonal Maps (CCZMs), there shall not be any requirement of NOC from the concerned Department(s). At present, the following Departments are having their CCZMs, the links of which are already available on the website of MCD:-

1. Delhi Metro Rail Corporation (DMRC)
2. National Monuments Authority (NMA / ASI).
3. Delhi Urban Arts Commission (DUAC)
4. Airports Authority of India (AAI)

The CCZMs of all of the above Departments have been superimposed in a single superimposed map prepared by the GSDI, Govt. of NCT of Delhi.

All these Departments have also issued the Circulars that there is no requirement of any NOC from them, in case the property is situated outside the influence Zone. The Circulars issued by these Departments in this regard are available on the website of MCD.

To have the uniformity in the process of sanction of building plan, this may be applicable in all the three Municipal Corporations.
