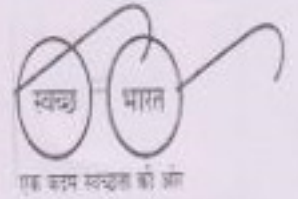

**CORRIGENDUM**


With the approval of Competent Authority, regarding issued raised by Vendor/Company in pre-Bid meeting held on 20.05.2020 at 12 PM before ADC(HQ) in his chamber regarding NIT for providing Security Service under the jurisdiction of EDMC is as under:-

S.No	Query	Clarifications by the Department
1.	Whether, Tender fees is exempted or Not.	Tender fees of Rs.1000/- Is payable.
2.	Whether, EMD is exempted or Not.	Exemption in R/o submission of EMD as per existing Govt. rules will be considered.
3.	Bank Solvency Certificate should not be more than Six months old.	This will be considered.
4.	Whether Bank Solvency will be acceptable for other department of not. Bank Solvency of Rs. 02 Crore or more is required	Clarification sought is not clear hence, not Considered
5.	Annual Turnover should be at least 5 Crore of Average Annual Turnover in last Three Years ending March 2019 and not each year during last consecutive three years.	Not Considered, however the word average in Clause 2.1 may not be read.
6.	Work order as per Annexure-IV page 24 of NIT, it should be last 7 years from submission of Bid.	Not considered however, three consecutive years "mentioned in the clause 2.1 of tender document may be read as " three consecutive years i.e. 2016-17,2017-18,2018-19 "
7.	3 completed works as per Clause 2.1 page 3 of NIT, it should be in last 7 years from submission of Bid.	
8.	Balance Sheet/ Turnover, it may kindly be clarified whether it should be self attested or certified by CA.	The books of Accounts must be Certified by the Chartered Accountant as per clause 2.1.
9.	ISO Certificate for Manpower, please mention the proper ISO No. of the Certificate required to be submitted.	ISO 9001:2015 is required.
10.	OHSAS Certificate has been required for 5 Years as per Annexure-IV page No.24 of NIT. It is submitted that it is not required in case of Manpower supplying Agencies.	OHSAS 18001:2007 is required.
11.	In Annexure-XI of NIT (Financial Bid) the rate should be per person per 8 hours shift (Per day) instead of monthly basis. The EPF, ESI, Relieving Charges, Bonus and GST are fixed elements as per Govt. Rule. Therefore only	Not Considered. Besides, both type of calculation yields the same output.

	administrative Charges should be asked to the bidder to quote in the Financial Bid.	
12.	Rate should be per person per day basis instead of per person per month.	
13.	Labour License as per Annexure-V, S. No. 8, Page 25 of NIT, it should be mandatory because it may be submitted after award of contract.	Not Considered. Besides, the evaluation of the tender done on the basis of credential of bidders at the time of bidding not after the award of contract.
14.	Location wise break up of Nos. of the workers to be deployed may please be intimated.	Not Considered. Besides, the nature of work at all the location are same.
15.	In the NIT at Page No. 17(Claue No.43) 33% of manpower is required in the category Ex-Service men. In this regard it is submitted that either rate as applicable to Ex- Servicemen may also be provided to the prospective bidders or there should not be more than 10% of Ex- Servicemen of the total required manpower.	Not Considered.
16.	The Evaluation Criteria parameters for the successful responsive bidders is not clear, it may please be transparently clarified. In case two or more bidders quote the same Administrative Charges in the Financial Bid.	It is already clarified/specified in Annexure IV of the Tender Documents that in case the financial bid of more one agency is same as responsive L-1 the work will be awarded to the agency which obtain maximum marks in technical evaluation.
17.	Last date for submission of technical bid i.e. 01.06.2020 be extended in view of COVID-19.	Considered, The last date of Submission of Bid is 08.06.2020 at 02 PM on the same venue.
18.	Visit of all the sites of EDMC where the instant service is to be provided cannot be undertaken due to enforcement of lock down.	Not Considered, in view of the fact that the concern has been raised by the existing service provider in EDMC and hence, the question of survey does not arise at all.
19.	The number of employee on role be mentioned.	The requirement of manpower on the roles of the bidders has been clearly mentioned in annexure IV of the tender document and the same will be utilized for technical evaluation of the tender.
20.	The GST is exempted or not	GST is the statutory dues and has to be paid by the bidders. And the same has been explicitly mentioned in annexure-XI of the tender document.
21.	In financial bid total column is not available for Sr. No.1 and 2. Meaning of grand total is not clear.	It is not clear as to what the bidder want to get clarified. However, the grand total is crystal clear in Annexure IV.
22.	Three work/two work order/ one work order (Period not mentioned.)	The period considered as from the date of establishment of the firm till the last date of submission of bid i.e. 08.06.2020.
23.	Nine work order or more are required (period not mentioned.)


24.	Deficiency observed by the department.	In Clause 3-B of Annexure-VIII, 120 days may be read as 90 days.
25.		Another column seeking the document in respect of PSARA registration added in Annexure-V.


