CIRCULAR

The Labour Department, Government of NCT of Delhi vide its Office Order No. F.No. 12(142)/02/MW/VII/Partfile/2044-2055 dated 18.06.2021 has revised the minimum rates of wages for the classes of Contractual Employees after enhancing the Dearness Allowances applicable w.e.f. 01.04.2021. Accordingly, the Competent Authority of EDMC has approved the payment of Dearness Allowance w.e.f. 01.04.2021 and revised rates of wages in the East DMC in respect of Contractual Manpower engaged on minimum wages basis (i.e. Data Entry Operators (DEO) & Multi Tasking Staff (MTS), Mali (for Horticulture Department), Asstt. Programmer 'A' Level, who are engaged through M/s. BECIL w.e.f. 22.09.2020 onwards or till further revision as shown in table below:-
