CIRCULAR

Sub.- Amnesty Scheme for waiving of Property Tax in unauthorized regularized colonies.

Reference is made to recent notification of Government of India regarding regularization of 1731 unauthorized colonies under the jurisdiction of Municipal Corporations of Delhi. Out of above, 256 unauthorized regularized colonies are falling under the jurisdiction of East DMC (List enclosed as Annexure)

As the Hon'ble Mayor of East Delhi has been pleased to grant anticipatory approval, it has been decided to roll out the Amnesty Scheme in respect of properties of these 256 unauthorized regularised colonies which are not in the records of Property Tax Department

As per the provisions of the scheme, property owner of residential properties in these unauthorized regularized colonies are required to pay the property tax for the Financial Year 2019-2020 & 2020-2021 and all the outstanding property tax dues prior to Financial Year 2019-2020 will be waived off. Further, property owners of non-residential properties in these unauthorized regularized colonies are required to pay the property tax dues of last three Financial Years including current Financial Year i.e. for Financial Years 2018-2019, 2019-2020 & 2020-2021 and all outstanding property tax dues prior to Financial Year 2018-2019 will be waived off. The benefit of the said Amnesty Scheme shall be available only on filing of Property Tax Return (PTR) and making all the payment of property tax dues without any interest and penalty by 31.01.2021
