Minutes of meeting chaired by Commissioner, East DMC on 15.03.2021 at 04:00 PM to discuss the issues related to survey of street vendors and PMSVANidhi scheme.

List of participants is at Anneuxre-I.

A meeting was held on 15.03.2021 at 04:00 PM under the chairmanship of Commissioner EDMC to discuss the issues related to survey of street vendors and PMSVANidhi scheme.

2. At the outset it was briefed that the deadline of completion of survey is 31.03.2021. During the meeting Commissioner, EDMC shows his displeasure on the pace of the survey work and directed the agencies to expedite the work and completed by 28.03.2021.
3. During the meeting Zonal authorities informed that the agencies do not have enough infrastructure required for survey work and they also have insufficient staff in field.
4. It was informed by representative of M/s AILSG that they have 4 teams in each zone of EDMC. Further, it was informed by them that members of TVCs are not co-operating them during survey.
5. Commissioner sought information regarding street vendors left out in survey. In response of the same M/s KASH IT informed that approx. 1500 vendors are remaining in Shah. North Zone and 600 vendors are remaining in Shah. South Zone. Further, M/s AILSG informed that they have surveyed approx. 4600 vendors in Shah. South Zone. It has also been informed by them that they have to complete survey in weekly markets in Shah. North Zone.

Directions have been issued by Commissioner to complete the survey by 28.03.2021. For this task, zonal LIs may be directed to expedite the survey process. It has also been directed by the Commissioner that announcement may be done in vending areas that only those street vendors will be allowed to vend who will register themselves in ongoing survey.

7. Commissioner directed HoD (IT) to get the data of street vendors from the agencies and keep it in EDMC database.
8. Commissioner also directed to expedite the process of PMSVANidhi scheme, since the progress of this scheme is being monitored at the PMO level. Data of left out applicants to whom LoR has been issued & the applicants whose applications have been rejected be obtained from SLBC to follow up.

The meeting ended with thanks to the chair.
