**Terms and Conditions:-**

1. The firms who are interested to quote their rates must have GST registrations & PAN No. The same may be endorsed on their quotation. Authorization certificate from manufacturer to be attached with quotation in case of distributors. GMP certificate of manufacturer to be attached with quotation.
2. ITR and Sales tax return for the previous year to be enclosed with quotation.
3. The rate should be quoted both in words and figures, overwriting, alteration or cutting should be avoided and if any should be attested. All pages should be numbered and signed by the authorized signatory of the firm. The quotation must un – conditional.
4. The quoted rates will hold be valid for six months from the date of opening of the quotations.
5. The Director (Ayush) reserves the right to reject any or all quotation without assigning any reason(s) thereof.
6. Successful bidder should submit Agreement on hundred rupees stamp paper at the time of supply.
7. Goods should be supplied within the period of 45 days of issue of supply order.
8. Each supply should accompany, testing reports of supplied medicines in standard format and medicines should be labeled with “EDMC supply not for sale”
9. Performance Security @ 5% of supply cost in the form of FDR in the name of Commissioner, East Delhi Municipal Corporation along with bills.
10. Payment will be made of rising of bill and approval of the supplied goods.
11. The Department will made efforts for timely release of payment .However no Interest shall be paid in case of delay in releasing the payments.
12. The firms are required to submit its offer complies with the quotation specification. Alternative rates in one quotation are not acceptable. If the tendered quote more than one offers, their quotation will be treated as in valid.
13. The firms are also required to submit the certificate, that rates offered are not higher than the rated quoted in any other Govt. Institution of NCT Delhi.
