CIRCULAR

Sub:- Revision of rates of Standard Licence Fee in r/o Residential Accommodations at difference Colonies of the North Delhi Municipal Corporation w.e.f. 01/07/2020.

The Directorate of Estates, Ministry of Urban Development, Govt. of India vide Office Memorandum No. 18011/2/2015-Pol.III dated 29-06-2020 (copy enclosed) has revised the rates of licence fee in respect of residential accommodations available in General Pool in terms of SR-324(4). SLF is revised/re-fixed after every three years which is based on the living area & category/type of flat and the rates are circulated by Govt. of India, Ministry of UD (Directorate of Estates). The same rates of SLF are adopted in toto by the MCD (now North DMC).

The enclosed revised rates of Standard Licence Fee are effective from 1st July, 2020 and as such, all the HODs/DCs of the Zones and the DDOs are requested to circulate this information amongst their respective officers/officials who are allottees of Mpl. Staff Quarters and take action to recover the revised licence fee/arrear of licence fee w.e.f. 01/07/2020 in accordance with the above mentioned office Memorandum. The revised rates of Standard Licence Fee are also available on the North DMC's website, www.mcdonline.nic.in at circular option in L&E Department.

OFFICE MEMORANDUM

Subject: Revision of flat rate of licence fee for General Pool Residential Accommodation (GPRA) throughout the country.

In terms of the provisions of the Rule 74 of the "Central Government General Pool Residential Accommodation Rules, 2017", the Government has decided to revise the flat rates of licence fee recoverable for the residential accommodations available in General Pool and also in Departmental Pools of Ministries/Departments of the Government of India throughout the Country (except in respect of standard/unclassified accommodation of Ministry of Defence, accommodation for service personnel of the Ministry of Defence and accommodation under the control of Ministry of Railways), as shown in the Annexure.

2. The revised rates of licence fee would be effective from 1st July, 2020. All Ministries/Departments are requested to take action to recover the revised licence fee in accordance with these orders in respect of accommodation under their control all over the country.

3. This issues with the concurrence of Integrated Finance Wing of the Ministry of Housing and Urban Affairs vide their note dated 15-6-2020.
