OFFICE ORDER

On the recommendation of the Union Public Service Commission, on the basis of result of CMSE-2015, offer of appointment for the post of GDMO-II was issued to Dr. Govind Madhav vide letter No.AO/CED/NDMC/HC(M)/2016/1842 dated 01.08.2016 and in response, he submitted his acceptance. After completing formalities i.e. Medical Examination and Police Verification, appointment order was issued vide office order No. A.O.(Estt.)/ASO(M)/CED/North/2017/1118 dated 01.06.2017. But at that point of time he was pursuing post graduation degree in General Surgery "Diplomat of National Board" from Jaipur Golden Hospital, New Delhi. Hence, he applied for extension of his joining. As per extent rule, extension in joining time cannot be granted beyond six month. Accordingly, with the approval of the Competent Authority, offer of appointment was cancelled vide letter No. AC(CED)/NDMC/2018/1391 dated 30.08.2018.

After completion of PG, he submitted application on dated 14.09.2018 for revival of lapsed offer of appointment along with affidavit mentioning therein that he ready to accept the depression in seniority due to late joining. So, with the approval of the Competent Authority dated 06.12.2018, letter sent to UPSC vide No. AC/CED/NDMC/2018/4323 Dated 26.12.2018 for revival of offer of appointment and UPSC approved the revival of lapsed offer of appointment vide letter No. F.No. 7/36/2019/E.XIII dated 16.12.2019.

Accordingly, with the approval of the Competent Authority, offer of appointment for the post of General Duty Medical Officer-II was issued vide No. ASO-III/AO/NDMC/Medical Cell/2020/3991 dated 13.02.2020, and he accepted the offer vide letter dated 24.02.2020. Thus, the Competent Authority vide its order dated 01.10.2020 approved the appointment of Dr. Govind Madhav S/o Sh. Sachit Kumar Jha, Roll No. 13248, Rank No. 158 Category- Gen. in North Delhi Municipal Corporation, for the post of General Duty Medical Officer, Grade-II, at level 10<sup>th</sup> of pay matrix under 7<sup>th</sup> CPC and other usual allowances admissible under the rules, regulations and orders applicable to the employees of North Delhi Municipal Corporation, on probation for a period of two years, subject to the following:-

1. He will draw his salary at the minimum of the pay at level 10<sup>th</sup> matrix under 7<sup>th</sup> CPC and other usual allowances.
2. He is being appointed after having been found medically fit by the Medical board of Hindu Rao Hospital.
3. Verification of Character and Antecedents has been received. It has been verified by Delhi Police that he does not reveal any criminal record related to him.
4. He is directed to report to Director (Hospital Administration), North Delhi Municipal Corporation, 12<sup>th</sup> Floor, Dr. S.P. Mukherjee civic Centre, New Delhi-110002, within 15 days of receipt of appointment letter positively for further posting, failing which the appointment will stand cancelled automatically without further notice.
