


1. Damage if any, caused to the Park & Greenery would be assessed by condition and your organization would be liable for the same.
2. Permission if any, of the District Magistrate, any other authorities, if necessary would be furnished by you to this office.
3. No cycle stand would be allowed to be run by you either inside or outside the park.
4. No advertisement shall be displayed on the ground without prior approval of the advertisement department.
5. The Corporation reserve the rights to cancel or withdrawn the permission at any time without assigning any reason.
6. No commercial activities shall be permitted inside the park premises.
7. The park shall be maintained properly and no in-sanitation should be spread.
8. The entire area will be kept clean free from traffic, congestion, pollution and noise pollution.
9. The religious function will be performed strictly during the timing allowed.
10. Infringement of any of the terms & conditions stated above for any of the rules and laws of the subject would be liable to cancellation of the allotment.
11. Fairs/Melas/Food-stalls (inside & outside the venues)/Jhoolas/Rallies/Exhibitions/Processions will not be permitted.
12. The permission for erecting of temporary tehbazary will be permitted after examination of case by licensing department and charging of requisite fees.
13. The above permission allowed by Dy. Commissioner/C.L. Zone/North DMC dated 15/10/2020.
14. The permission is subject to NOC from Police authority and Fire authority.
15. No single use plastic will be used by the applicant/samiti while holding function in Mpl. Premises, failing which they will be liable for punitive action as per relevant provision of the Act.
16. The organizer(s) of the event as well as other persons take effective measures issued by the Delhi Disaster Management Authority vide office order No. F. 24/DDMA/COVID/2020/329 dated 11/10/2020 (copy enclosed).
