OFFICE ORDER

Further, consequent upon opening of sealed cover, Sh. Rajesh Kumar Mishra S/o Sh. Raj Kumar Mishra, AE(Civil) on regular basis, Sty. No. 375(UR), East DMC, is hereby granted regular promotion to the post of Executive Engineer (Civil), w.e.f. 13.07.2017 notionally, i.e. the date after expiry of COP, in Pay Band-3, Rs. 15600-39100 + Grade Pay Rs. 6600/- revised to level 11 of Pay Matrix as per 7th CPC& posted in the same Corporation presently officer is working. Monetary benefit on the higher post will be admissible only from the date of actual promotion order, subject to outcome of Court Cases/Stay, if any pending in the court of Law.

Further, consequent upon his regular promotion as EE(C), the name of Sh. Rajesh Mishra is hereby inserted at serial No. 36-A i.e. below the name of Sh. Himanshu Shekhar Singh S/o Sh.
