**OFFICE ORDER**

(iv)	The ad-hoc appointment can be terminated at any time without assigning any reason and giving any prior notice as and when required.
(v)	The above said ad-hoc appointment shall be further subject to the instructions/guidelines issued by the Government of India./Corporation from time to time in this regard.
(vi)	The ad-hoc appointment shall be further subject to the decision of the Court Case(s)/stay, if any.
