SHOW CAUSE NOTICE

On administrative exigency/due to functional need of the department, Sh. Kuldeep S/o Sh. Birhama, Driver, BMID No. 10028561, was transferred from DEMS, NRZ to Director (V.S.) vide Office Order No. AO/ASO-V/CED/NDMC/2020/614 dated 25/08/2020 but he has not complied the transfer/posting order despite issuance of orders for stoppage of his salary and warning of initiation of disciplinary action against him; issued vide a further Office Order No. AO/ASO-V/CED/NDMC/2020/808 dated 17/09/2020. This is a serious lapse on the part of Sh. Kuldeep, Driver, NRZ and clearly the dereliction of duties and disobedience of the orders of the higher authorities.

Kuldeep, Driver, is hereby, directed to explain the reasons that why disciplinary proceedings should not be initiated against him due to non compliance of transfer/posting orders of CED issued vide Office Order No. AO/ASO-V/CED/NDMC/2020/614 dated 25/08/2020 and also despite issuance of orders for stoppage of his salary and warning of initiation of disciplinary action against him; issued vide a further Office Order No. AO/ASO-V/CED/NDMC/2020/808 dated 17/09/2020; issued with the approval of the Competent Authority.

The explanations of Sh. Kuldeep, Driver, Narela Zone, must reach the undersigned within 03 days of the receipt of this show cause notice, failing which disciplinary proceedings will be initiated against him without any further notice.
