**OFFICE ORDER**

Keeping in view of the exigencies of works in Civil Wing of Engineering Department, North DMC and in the Municipal interest, the Competent Authority has approved assigning of the look after charge to the post of Chief Engineer (Civil), North DMC to Shri Mahavir Prasad S/o Sh. Mohan Lal, presently working as Superintending Engineer (Civil), on ad-hoc/ North DMC in his own pay scale, without any extra remuneration, as a stop gap arrangement, till further orders and subject to Court case(s), if any.

2. Further, the officer is also assigned the charge of Chief Engineer (Bldg.) along with Chief Engineer (DEMS) & Chief Engineer (Mpl. Lab) with immediate effect. As CE(Bldg.), the officer will report directly to Addl. Commissioner(Engg.) and as CE(Mpl. Lab), C.E(DEMS), the officer will report to Engg-in-Chief and Director-in-Chief respectively.

3. The above said look after charge shall be following on the usual terms and conditions:-

(i)	The assignment shall be purely on look after charge basis in his own pay scale without any extra remuneration, as a matter of stop gap arrangement and shall not entitle the official(s) to claim any benefit/any additional pay on account of the said arrangement.
(ii)	The assignment of look after charge basis is subject to pending regular/ad hoc promotion in accordance with the RRs and will not confer any privilege or right on the official for ad-hoc/regular promotion or seniority to the said post.
(iii)	The period of service rendered on the assigned look after charge shall not count as qualifying service for promotion to the higher grade or for seniority, whatsoever.
(iv)	The said assignment can be terminated at any time without assigning and reason or given any prior notice, as & when required.
(v)	The assignment shall be subject to the outcome of the pending Court Case(s)/Stay, if any.
(vi)	The arrangement is subject to the Undertaking that the officer will not claim any undue benefit on this account, except as per the provisions of existing RRs. The Undertaking should reach the Central Establishment Department within a week's time of taking up the new assignments.

4. Consequent upon assignment of look after charge of Chief Engineer (Civil), the above said officer is directed to report to Addl. Commissioner(Engg.), North DMC.
