OFFICE ORDER

North Delhi Municipal Corporation has accorded approval vide Corporation Resolution No. 239 dated 28.12.2020 on acceptance of the recommendations of the 5th Central Pay Commission and in accordance with the action taken by various Ministries/Departments in Government of India, to encadre various ex-cadre posts i.e. Assistant Director, Deputy Director & Director existing in O&M Department of North DMC into General Cadre i.e. Administrative Officer/Assistant Assessor & Collector, Assistant Commissioner/Deputy Assessor & Collector and Additional Deputy Commissioner/Joint Assessor & Collector respectively in North DMC. Further the seniority shall be given from the date of appointment as Asstt. Director (O&M) on regular basis. However, the Officer shall be placed at the bottom in the year. Further, the juniors who have already been promoted to the post of Asstt. Commissioner/Dy. A&C before the date of merging of this cadre shall not be reopened.

- The Recruitment Rules (RRs) of the various posts of General Cadre in CED shall be applicable to all encadred posts of O&M Department. All existing/proposed RRs of various posts in O&M Department stand repealed simultaneously.
