OFFICE ORDER

On the recommendation of the Union Public Service Commission, on the basis of result of CMSE-2015, offer of appointment for the post of GDMO-II was issued to Dr. Suman Meena vide letter No. AO/CED/NDMC/HCM(0)/2016/1993 dated 01.08.2016 and in response, she accepted the offer of appointment, but she has not turned up for completion of necessary formalities. At that point of time she was pursuing post graduation degree in 'M.D Pathology' from Rajasthan University of Health Sciences, Jaipur. As per extant rule, extension in joining time cannot be granted beyond six month. Accordingly, with the approval of the Competent Authority, offer of appointment was cancelled vide letter No. AC/CE/DYNDMC/2018/1439 dated 30.08.2018.

After completion of PG, she submitted application on dated 22.08.2019 for revival of lapsed offer of appointment along with affidavit mentioning therein that she is ready to accept the depression in seniority due to late joining. So, with the approval of the Competent Authority dated 26.09.2019, letter was sent to UPSC for revival of offer of appointment and UPSC approved the revival of lapsed offer of appointment vide letter No. F.No. 7/29/2019/E.XIII dated 11.03.2020.

Accordingly, with the approval of the Competent Authority, offer of appointment for the post of General Duty Medical Officer-II was issued vide No. AO/NDMC/Medical Cell/2020/962 dated 06.10.2020, and she accepted the offer vide letter dated 27.10.2020. Thus, the Competent Authority vide its order dated 08.03.2021 approved the appointment of Dr. Suman Meena D/o Sh. Keshar Singh Meena, Roll No. 8927, Rank No. 1146, Category- ST in North Delhi Municipal Corporation, for the post of General Duty Medical Officer, Grade-II, at level 10th of pay matrix under 7th CPC and other usual allowances admissible under the rules, regulations and orders applicable to the employees of North Delhi Municipal Corporation, on probation for a period of two years, subject to the following:-

1. She will draw her salary at the minimum of the pay at level 10th matrix under 7th CPC and other usual allowances.
2. She is being appointed after having been found medically fit by the Medical board of Hindu Rao Hospital.
3. Verification of Character and Antecedents has been received. It has been verified by Delhi Police that she does not reveal any criminal record related to her.
4. Caste Certificate has been verified by the Concerned Authority.
5. She is directed to report to Director (Hospital Administration), North Delhi Municipal Corporation, 12th Floor, Dr. S.P. Mukherjee civic Centre, New Delhi-110002, within 15 days of receipt of appointment letter positively for further posting, failing which the appointment will stand cancelled automatically without further notice.
