Sub.:- Re-commencement of Training Classes for Part-II candidates of SOGE and booking of venue.

Sir,

The training classes for Section Officers' Grade Examination, 2020 was commenced w.e.f. 2nd March, 2020 vide Office Order No. 182 dated 27.02.2020. But due to outbreak of COVID-19 epidemic and declaration of lockdown w.e.f. 22.03.2020, the training classes of Part-I and Part-II were suspended w.e.f. 20.03.2020 till the situation becomes normal.

The suspended training classes of Part-I and Part-II were re-started w.e.f. 26th October, 2020 and the classes of Part-I were completed on 20th November, 2020. As the training classes of Part-II were in progress but in the light of high increase of Corona cases in Delhi and restriction in gathering of not more than 50%, the training classes were suspended w.e.f. 23.11.2020 till further orders.

Now, the situation of COVID-19 epidemic is under control as Cinema Hall, Schools for Classes of 10 to 12 have been re-opened in Delhi, the Competent Authority has decided to re-start suspended training classes for Section Officers' Grade Examination, Part-II w.e.f. 15.02.2021. The faculty members for the training of the Part-II Exam will remain same.

The participants of Part-II and Lecturers are also advised to wear mask, wash hands frequently or use sanitizer and maintain social distance in the Lecture Hall as per guidelines issued by the Govt. of India. No candidate will be allowed to enter in the Lecture Hall without face mask.

The F&G Section of North Delhi Municipal Corporation may be requested for booking of the venue at Civic Centre for the classes/lectures commencing from 15th February, 2021 to 24th March, 2021 (for Part-II candidates) from 9.30 AM to 12.45 PM under information to this office. There are 82 candidates of Part-II candidates to attend lectures and we may requires Aruna Asaf Ali Sabhagar, 4th Floor to maintain social distancing for such a large participants in class room in the morning session from 9.30 AM to 12.45 AM for Part-II candidates may be booked.
