In exceptional cases of open tenders and where procurement is done through sources other than GeM and where publicity of tenders is required through newspapers, the prior approval of Engineer-in-Chief shall be obtained before publishing.

However, Publishing of tenders through divisional notice boards shall continue to remain in all type of tenders.

OFFICE ORDER

But owing to outbreak of Corona virus pan India and complete lockdown during the months of April & May, 2020, property taxpayers could not avail of Amnesty Scheme fully. In order to facilitate the property taxpayers, the competent authority vide orders dated 09.06.2020 has been pleased to extend the present Amnesty Scheme upto 30.06.2020 on the same terms and conditions as stipulated in the department's office order dated 18.03.2020 and 19.03.2020.


