The Executive Engineer (DEMS) HQ-III, on behalf of Commissioner, North DMC invites

2. The Applicant must meet the following technical and financial capacity requirements:

#### **Technical Capacity**

The Applicant or the members of the Applicant Consortium whose technical experience will be evaluated for being qualified for this Project should have experience of successful completion / operation for the work of Collection, Transportation and Disposal (with or without processing) or Processing (with or without collection & transportation) of Municipal Solid Waste / Plastic Waste during the last seven years ending last day of month previous to the one in which tenders are invited as per following criteria:

- i) Three works of minimum capacity of 20 TPD or
- ii) Two works of minimum capacity of 30 TPD or
- iii) One work of minimum capacity of 40 TPD

The Applicant should furnish the required Project-specific information and evidence in support of its claim of Technical Capacity.

#### **Financial Capacity**

The Applicant or the collective members of the Consortium must have an average annual financial turnover of at least Rs. 25 Crores during the immediate last three

consecutive financial years. This should be duly audited by Charted Accountant. Year in which no turnover is shown shall also be considered for working out the average.

The Applicant must provide either solvency certificate amounting to Rs. 20 crores duly certified by scheduled bank

or

Net worth Certificate of Rs. 5 Crores (as on end of last financial year) issued by certified Chartered Accountant.

The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheets, duly certified and audited by the Chartered Accountant. The balance sheet in case of Pvt./Public Ltd. company means its standalone finance statement and consolidated financial statement both.

- 3. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority as specified in the order issued by Ministry of Finance vide F.No.6/18/2019-PPD dated 23/07/2020. This order shall be considered as part of this RFP. Certificate regarding compliance with this order also required to be submitted.

- 8. Bidders have to deposit Bid Security / Earnest Money of Rs. 60,00,000/- (Rs. sixty lakh only) online on e-tendering portal of North DMC. The Earnest Money of unsuccessful Applicants will be refunded immediately after the expiry of stipulated bid validity period or immediately after acceptance of the successful bidder, whichever is earlier. No interest will be payable under any circumstances on delayed refund of Earnest Money. Earnest Money of successful applicant will be adjusted against Performance Guarantee.
- 9. The successful bidder will have to furnish the Performance Guarantee of Rs. 1,50,00,000/- (Rs. One crore fifty Lakh only) out of which Rs. 1,10,00,000/- (Rs. One crore ten lakh only) in the form of Bank Guarantee within seven days of issue of L.O.A. Out of Rs 60 lakh Bid security, Rs 40 lakh will be retained as part of PG and Rs 20 lakh will be refunded. The Bank Guarantee of Rs. 1,10,00,000/ submitted as Performance Guarantee will be released after six months of COD. Balance amount Rs.40,00,000/- will be retained as Performance Guarantee till the completion of concession period. North DMC shall not be liable to pay any interest on the Performance Guarantee and the same shall be interest free.
