Notice for Inviting Expression of Interest (EOI)

Subject: Empanelment of Waste Management Agencies with North DMC

The Executive Engineer (DEMS) HQ, on behalf of Commissioner, North DMC invites Expression of Interest (EOI) from Waste Management Agencies, through online applications on North DMC website, for 'Empanelment of Waste Management Agencies with North DMC' for the work of segregation and collection of plastic waste from waste collection centres, Solid waste dumping grounds, biomining of legacy waste, areas under the jurisdiction of North DMC, and its transportation to recycling / processing facilities for scientific disposal as per PWM Rules and CPCB guidelines.

After Empanelment of Waste Management Agencies, North DMC will invite bids separately from Empanelled WMAs only on the basis of Royalty per MT (to be paid to North DMC) of plastic waste collected from the jurisdiction of North DMC. Highest offered royalty would be basis of selection of WMAs. North DMC may engage one or more WMAs at matching rates of highest royalty offered. Selected / Engaged WMAs will be required to furnish documentary proof / evidence of collection of plastic waste and also for its disposal at recycling / processing / waste to energy / cement plants etc.

The total area under the jurisdiction of North DMC is approx. 636 sq. km which is divided into six zones namely City-SP, Karol Bagh, Civil Line, Keshavpuram, Rohini & Narela Zone. In the area under North DMC 4500 MT (average) of Municipal Solid Waste (MSW) is generated on daily basis. The quantity of plastic waste generation is around 10% of total quantity of MSW i.e. 450 MT (average) per day which includes both recyclable and non-recyclable fraction.

North DMC, itself and through its concessionaires is engaged in providing municipal services that includes street sweeping, collection & transportation of MSW to Bhalswa landfill and Narela-Bawana waste processing facility for disposal. At present, the Plastic Waste generated in North DMC area is dumped on roadsides, community waste bins, dhalaos (masonry waste storage depots). North DMC plans to divert this waste away from land disposal by promoting the reuse, recycling and processing of plastic waste.

Eligibility Criteria

In order to be considered for empanelment as Waste management Agency, the Applicant must meet the following technical and financial capacity requirements as stated below:

Technical Capacity

Any of the following:

1. Should have experience of successful completion / operation for the work of Collection, Transportation and Disposal (with or without processing/ recycling) of Municipal Solid Waste / Plastic Waste of minimum two years during the last seven years.

2. Should have experience of Processing/recycling (with or without collection & transportation) of Municipal Solid Waste / Plastic Waste of minimum two years during the last seven years.
3. Should have valid documents issued by State Pollution Control Board (SPCB) / Pollution Control Committee (PCC) for operation of Processing / recycling / waste to energy plants of Municipal Solid Waste / Plastic Waste.
4. Should have valid agreement with recyclers, processors and WTE plants etc. for supply of Plastic Waste.

The Applicant should furnish the required specific information and evidence in support of its claim of Technical Capacity.

Financial Capacity

Assuming the minimum expenditure to be incurred for this work to the tune of about 25 lakh, the applicant must provide:

Either solvency certificate amounting to Rs. 10 lakh duly certified by scheduled bank
or
Net worth Certificate of Rs. 2.5 lakh issued by certified Chartered Accountant.

The application is required to be submitted as per format given in Annexure-I on website www.mcdonline.nic.in / ndmc portal → Important Link

In first phase, applications received online up to 26/07/2021 shall be considered for empanelment as Waste Management Agency and bids shall be invited only from agencies empanelled in first phase.


