If the rates quoted by the lowest tender are found abnormally low, the payment to the contractor for the work shall only be made after inspection by Quality Control Cell at different stages and the findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by contractor. In case the lowest contractors fails to commence/ complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per provisions of the enlistment rule/ instruction issued from time to time. The testing of the works / supplies shall be got done in accordance of office circular No- CVO/Vig./05/2289 dt 17-5-05 and charges of test also be borne by the contractor accordingly. Circular-No- E.E.-(P)-III/2005-06/D-398-dt 17-6-2005-is-applicable. The cement-/steel, if any, will-be-procured by the contractor as per terms & conditions of NIT. In case of holiday, the tenders will be sold/ issued/ received on the next working day. The responsibility of correctness and genuineness of all the documents submitted by the contractor solely lies on the contractor.
