**OFFICE ORDER**


Consequent upon decision in RDA No. 3/32/2021 vide order No. 3/32/2021/ Vig./P/ 2022/141 dated 25.04.2022 vide which no penalty has been imposed upon him and as per report of Vigilance Department/North DMC (now MCD) communicated vide letter No. ALO (VCR)/Vig./2021/976 dated 05.05.2022 and subsequent upon opening of sealed cover under the provisions of DoP&T O.M. dated 14.09.1992 and in accordance with the recommendations of the DSC dated 05.04.2022, Shri Deepak Tyagi S/o Sh. Shiv Raj Tyagi, (UR) (Sty. No. 177 (NDMC) and 1066 (combined seniority)), Junior Engineer (Civil) is hereby granted ad-hoc promotion to the post of Assistant Engineer (Civil) in Pay Matix-7 as per 7<sup>th</sup> CPC, notionally w.e.f. 05.04.2022, i.e. the date, when his junior Shri Hemant Singh Negi (Sty. No. 178 (NDMC) and 1067 (combined seniority)), was promoted, which was notified vide ~~CED's~~ O.O. No. AO/Engg./HQ/ NDMC/2022/013 dated 05.04.2022 and actual promotion from the date of his joining.

2. The above said ad-hoc appointment to the post of Assistant Engineer (Civil) shall be subject to the following terms and conditions:-

(i)	The appointment shall be purely on ad-hoc basis, as a matter of stop-gap arrangement and shall not entitle the officer to claim any benefit on account of the said promotion.
(ii)	The appointment is on ad-hoc basis, pending regular appointment in accordance with the Recruitment Regulations and will not confer any privilege or right on the officer for regular appointment to the said post.
(iii)	The period of ad-hoc service will not be counted towards eligibility period for regular appointment or determination of seniority.
(iv)	The ad hoc appointment can be terminated at any time without assigning any reason and giving any prior notice as and when required.
(v)	The above said ad-hoc appointment shall be further subject to the instructions/guidelines issued by the Government of India/Corporation from time to time in this regard.
(vi)	The ad-hoc appointment shall be further subject to the decision of the Court Case(s)/stay, if any.
(vii)	The ad hoc appointment will be further subject to the condition that as & when any senior officer becomes eligible for promotion on ad-hoc basis, the junior most officer will be reverted back to accommodate his senior(s).

Consequent upon ad-hoc promotion to the post of Asstt. Engineer (Civil), official is hereby directed to report to Engineer-in-Chief -II for further duties.
