#### **Terms and Conditions:**

The rates should be valid for six months from the date of opening of this quotation.

Supply is to be arranged by the firm within stipulated period of 15 days.

Security deposit of 5% of total value of supply order is to be submitted in the form of FDR favouring Commissioner, North Delhi Municipal Corporation at the time of supply.

Each supply should accompany a test report on Form 50 from Government approved laboratory.

The Supply should comply with the provision of the Drug and cosmetics Act, 1940 and amendments made there under.

The firm has to remove the rejected part material from this office within three days of the intimation, at their own cost.

No firm will be eligible to withdraw its rates after the submission of the quotation/tender.

The rate shall be quoted in figures as well as in words and shall be protected with transparent tape, failing which the bid shall be rejected.

\*Rate of each tablet may be mentioned in the quotation for Ayush-64 and Samshamani Vati 500 mg. If mentioned in the units of gms, the number of tablets in each pack/unit should be in quotation letter.

Any contradiction to the above, terms and conditions, the bid is liable for rejection.

No cartage/transportation charges will be given for the supply received.

Payment will be made on raising of bill and approval of the goods.

Quotee must fulfill the general condition of the quotations.

The Supply should be marked /labelled as "North DMC Supply, Not for Sale"
