2. Contractor registration form with details and document and photo upload provisions.
3. Provision to capture Latitude and Longitude in the form and its display in web map.
4. User Login page with password reset/forget option.
5. Dashboard welcome page with user application menu options.
6. Grid based display of details of contractors and their payment history.
7. Develop in-built payment calculation logic and provide payment screen integrating with existing Payment Gateway of corporation.
8. Also integrate email and SMS gateway for alerts and information to users and department concerned officers.
9. Develop officer role module to manage users activation & deactivation, masters values etc.
10. Develop admin module with full access and permission rights to make necessary modifications in the module and master tables.
11. Develop various sets of MIS reports based on certain parameter such as contract-wise payment history, month-wise payment, pending payments, expiry of contractor in a month etc.
