<u>Terms and Conditions for inviting Animal Welfare Organisations (AWOs)NGOs/Private Veterinary Doctors for Sterilization & Immunization of Stray Dogs in SDMC under Animal Birth Control (ABC) Programme</u>

- 1. The South Delhi Municipal Corporation (SDMC) invites applications from interested NGOs/Animal Welfare Organizations (AWOs) recognised by the Animal Welfare Board of India and registered under the Societies Registration Act, 1860/ Private Veterinary Doctors having a degree of B.V.Sc. & A.H. and registered with Delhi Veterinary Council/ Veterinary Council of India for sterilisation & immunisation of stray dogs under Animal Birth Control (ABC) Programme at the centre established by SDMC at Centre No. 02, Sector-29, Dwarka and Veterinary Hospital/GNCTD at Mundhela.
- 2. The NGOs/AWOs/ Private Veterinary Doctors should have adequate staff (technical & non technical) and preferably vehicles as well for picking up and releasing of sterilised dogs back to the same area from where they had been picked up. However, the dog pickup van may also be provided by SDMC depending upon the availability of the vehicles.
- 3. All interested NGOs/ AWOs/ Private Veterinary Doctors shall have to undertake the work of sterilisation and immunisation of stray dogs as per the Animal Birth Control (Dogs) Rules 2001 and Standard Operating Procedures for sterilisation and Immunisation of stray dogs issued by the Animal Welfare Board of India (AWBI), a statutory body of Ministry of Environment & Forests Govt. of India. All interested NGOs/AWOs/Private Individuals/ Private Veterinary Doctors are requested to go through the above rules and SOP which are available at the website of AWBI.
- 4. All would have to abide by the rules & regulations of the Corporation, Animal Welfare Board of India and Govt. Of India, issued/amended time to time regarding Animal Birth Control Programme.
- 5. The area of sterilisation and immunisation of stray dogs would cover the area of Najafgarh and West Zone. However, the SDMC may ask to sterilize the stray dogs of other zones i.e. South and Central Zone.
- 6. The SDMC shall fix monthly target for sterilization and immunization of stray dogs which is to be met by the applicant.
- 7. The NGOs/AWOs/ Private Veterinary Doctors shall have to preserve the genital organs of the stray dogs sterilised by them till their counting by the joint inspection team.
- 8. The payment of the cost of sterilisation of stray dogs shall be reimbursed as per rates approved by the Corporation from time to time after counting of genital organs of sterilised dogs, by a Joint Inspection Team. Existing cost of sterilization of stray dog and immunization against rabies is Rs. 1000/- per dog picked up, sterilized and released back by the NGO/AWO/ Private Veterinary Doctors and Rs. 900/- per dog picked up the SDMC, sterilized, immunized and released back by the NGOs/AWOs/ Private Veterinary Doctors.
- 9. NGOs/AWOs/ Private Veterinary Doctors interested to be associated with the programme for sterilisation & immunisation of stray dogs may send their application with all required details in hard copy to the Dy. Director (VS)/RCP, Department of Veterinary Services,

- 10. The last date for submission of application is 01.06.2021.
- 11. The interested NGOs/AWOs/ Private Veterinary Doctors may also submit the additional information relevant to the work in addition to the information sought in Proforma.
- 12. No applicant shall be allowed to withdraw from the work before a period of one year w.e.f the date of issuance of letter to work by SDMC. If anyone wants to withdraw from the work, he would have to give two months prior notice to the Dy. Director (VS)/RCP failing which action shall be taken by the SDMC including debarring and black listing the applicant from the work of sterilization in future in SDMC.
- 13. If SDMC is not satisfied with the work of sterilization, the Corporation may ask the applicant to stop the work by giving him a 02 months notice.
- 14. The SDMC may withdraw this public notice at any time without assigning any reason thereof.
- 15. The NGOs/AWOs/ Private Veterinary Doctors will provide daily/weekly report on sterilization of stray dogs, to the SDMC on e-mail provided by SDMC.
