Subject : Engagement of Two Consultant Engineers (Environment) in DEMS (HQ) of Municipal Corporation of Delhi.

Two (02) experienced Consultant Engineers (Environment) on the monthly consultancy fee of **Rs.67,700 + Variable DA per month** is required to be engaged in DEMS (HQ), Municipal Corporation of Delhi on contract basis for a period of one year. No other allowances shall be payable apart from above remuneration, during the period of engagement.

2. The minimum eligibility criteria for the engagement of Consultant Engineer (Environment) are as under:-

Essential Educational qualifications and work experience:-

- I. **Education Qualification** :- Master's/Ph.D in Environmental Science/ Sustainability /Business Sustainability Management / Environmental Sustainability Management
- II. **Work Experience**: - Minimum 4 years of relevant experience in Solid Waste Management, Swachh Bharat Mission (Urban) 2.0 Policy support, stakeholder engagement, and inter-departmental coordination, from an organisation of repute.

3. The Terms and conditions for the engagement of Consultant Engineer (Environment) shall be as under:-

- (a) The engagement is purely on contract basis for a period of One Year.
- (b) The engagement being purely temporary can be terminated without assigning any reason or giving any notice.
- (c) The contract will stand automatically terminated after one year from the date of joining unless the same is further extended in writing.
- (d) The consultant will be entitled to one day casual leave in a month and will not be entitled to any other kind of leave.
- (e) The consultant will not be entitled to any benefit of Provident Fund, Pension, Gratuity, Bonus, Medical Allowance Treatment, Seniority, TA, increments or any other benefit which are applicable to the Municipal Employees/Govt Servants, appointed on regular/ad-hoc basis.
- (f) The applicant will not be granted any claim/right for regular/ad-hoc appointment to the post or any other benefit.
- (g) Medical Fitness Certificate from a qualified Medical Officer will have to be furnished prior to joining.

- (h) The consultant will not be entitled to any TA for taking up the assignment.
- (i) If any irregularities/discrepancies are noticed, Consultant will be liable for action under the provisions of Act/Rules/Codes etc. including dis-engagement of the contractual service in MCD.
- (j) The Consultant should not have been convicted by any court and not booked under IPC. There should be no criminal case pending against him at the time of entering into Contract.
- (k) The consultant should not have been removed / dismissed from service by his previous employer(s) due to any misconduct/embezzlement.
- (l) The consultant is also liable to abide by the rules and regulations which will be not been incorporated in the offer letter.
- (m) An undertaking to the above (a) to (l) should be furnished by the Consultant Engineer (Environment).
- (n) In case of any dispute in service matters, the decision of the Commissioner, MCD shall be final & binding and will have to abide by all the orders passed by the Commissioner, MCD, in any matter whatsoever.
