- 3) The proposed calender of events of your department (upto August, 2022) may also be sent to this department

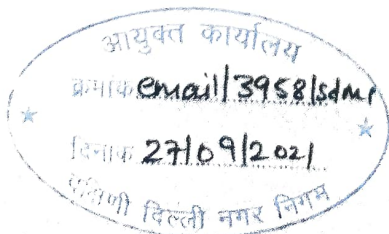
