4. The appointment and services will be governed under-Residency Scheme Govt. of India, Ministry of health and Family welfare and amendment thereafter)/relaxation as detailed in eligibility criteria.

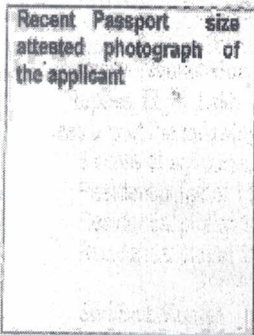
