AUCTION NOTICE

In pursuance of the decision by the Horticulture Department (HQ) Municipal Corporation of Delhi (MCD), this public notice is hereby issued for the auction of Metal Waste lying at the Waste to Wonder Park, Sarai Kale Khan.

Auction Details:


1. **Metal Waste:** There is some metal waste lying unused of varying dimensions having approximately 1500 to 2000 Kgs. available for auction and minimum bid price will be Rs.33/- Per Kg.
2. **Auction Panel:** An auction panel / committee has been constituted to oversee the auction process, ensuring transparency and fairness. The panel consists of the following members:

3. **Date and Time:** The auction will take place on 19th December, 2023, at 11:00 AM. Registration for the auction will commence at 10:00 AM.
4. **Location & Entry :** The auction will be conducted at Waste to Wonder Park, Sarai Kale Khan, Delhi. Entry is permitted only with a valid ticket (entry fee), similar to all visitors of the park. 5. **Viewing:** Interested parties are encouraged to inspect the waste material before the auction. Viewing will be possible between 10.00 AM to 5.00 PM and at 09:00 AM on the date of auction. No separate catalogue will be provided.
6. **Terms and Conditions:** Bidders are required to adhere to the terms and conditions of the auction, which are provided below:
 - a. All bidders must register at the auction venue before participating. Registration requires providing valid identification and contact information.
 - b. Bidders are encouraged to inspect the designated waste material before the auction.
 - c. All bidders are required to submit a mandatory Security Deposit of Rs.10000/- at the time of Registration. The Security deposit should be submitted in the form of a Demand Draft / Pay Order payable in favour of "COMMISSIONER, MCD". The security amount will be returned on the same day to unsuccessful bidders. However, for the successful bidder, it will be refunded / returned after 15 working days.
 - d. Successful bidders must make full payment immediately or within two working from the close of the auction.

- e. Failure to make payment within the stipulated time may result in disqualification. The security deposit will also be forfeited, if the successful bidder fails to deposit the required bid amount within two working days.
- f. Details of accepted payment methods will be provided during registration.
- g. The metal waste material lying at site are sold "as-is where is" and no warranties or guarantees are provided regarding their condition.
- h. The bid increment is set at Rs.1/- Per Kg. Bidders must increase their bids by at least this amount during the auction.
- i. There is no reserve price for of the material will be sold to the highest bidder and material will be weighted in the presence of successful bidder presence of the waste material for arriving total value of the auctioned material.
- j. The Municipal Corporation of Delhi (MCD) reserves the right to withdraw any material from the auction without prior notice.
- k. The highest bidder will be declared the buyer, subject to approval by the Panel.
- l. In the event of a dispute, the decision of the auctioneer or the designated MCD official-Chairman of the Committee / Panel for the auction will be final.
- m. Buyers must remove purchased material from the auction site within 2 days from the date of deposition of full amount failing which the materials will become the sole property of the MCD. Any costs associated with the removal, transportation, or dismantling will be the sole responsibility of the buyer.
- n. The bid price does not include any applicable taxes or fees, which will be added to the final purchase price as required by law.
- o. Bidders must comply with all relevant laws and regulations related to the auction, including any environmental or safety requirements.
- p. In case of any damage or loss to Municipal or private property or to any individual during the removal of waste / auctioned material the contractor will be wholly responsible and the M.C.D will not be at all responsible for such acts of negligence on the part of the contractor.
- q. By registration for auction or bidding, the bidders are bound to accept all the terms & conditions of the Auction.
- r. The Municipal Corporation of Delhi reserves the right to accept or reject any bid without assigning any reason thereof.
