AUCTION NOTICE

The Executive Engineer(Elect)-I/SNZ, MCD, invites on behalf of the Commissioner MCD bids for auction of unserviceable electrical material. The auction for unserviceable material(3 Nos. condemned DG Sets) lying at J.E.(E)-I store at Swami Dayanand Hospital will be held on 14/09/2023 at 11.30 AM under Electrical Division-I Shahdara (North) Zone on as is where is basis. Dismantled material to be auctioned is earmarked at site/store. Following are the terms & conditions:

1. It is not incumbent to accept the highest bid.
2. The highest bid can be rejected without assigning any reason.
3. Auction process may be cancelled without assigning any reason. Decision of MCD officials will be binding and final to all.
4. Persons/firms taking part in auction will have to submit copies of GST Registration Certificate , PAN Card and Aadhar card. **Without above documents, NO Persons/firms shall be allowed to participate in auction process.**
5. **No bidder will be allowed/entertained in auction process after 11.30 AM in any circumstances.**
6. Persons/firms taking part in auction will have to deposit Rs.20,000/- only in the form of Demand Draft issued by any scheduled bank in favour of the **Commissioner, MCD** as Earnest Money. The Earnest Money of the unsuccessful bidders will be returned after acceptance of the highest bid.
7. The highest bidder will have to pay 25% amount on the spot at the time of the fall of the hammer and remaining 75% amount to be deposited in the form of DD in favour of **Commissioner, MCD** within 3 working days of closing of auction.
8. 2% GST of bid amount shall be deposited by the successful bidder in the form of **Demand Draft in favour of Ex. Engineer(E)-I/Shah North Zone.** It shall be deposited alongwith remaining 75% amount. 2% GST will be deposited by MCD and balance GST (as applicable) will be deposited by successful bidder/firm to Tax Authority as per rules.
9. After, receipt of full bid amount along with 2% GST, Acceptance Letter/Work Order will be issued.
10. In case of bidder fails to deposit the full bid amount in stipulated time, the Earnest Money + 25% amount deposited by the bidder, shall be forfeited.
11. The Bidder/Firm would remove items from the store etc. within seven days of Acceptance Letter/Work Order. The department will not bear responsibility for any damage by way of pilferage, fire or any other unforeseen calamity.
12. Material/items will be removed from the site in the presence of the bidders himself or his agent duly authorized by him in writing after approval of the competent authority.
13. The item/material to be auctioned be seen in the store of J.E. (Elect)-I at Swami Dayanand Hospital under EEE-I Shahdara (North) Zone, on any working days from 2 PM to 5 PM. **Item/material inspection will not be allowed on the day of auction.**
