PUBLIC NOTICE FOR AUCTION


The unclaimed seized articles/ goods removed from the Public/ Municipal land/ footpath during the course of encroachment drive by Licensing Branch, City S P Zone during 2013 to 2023 will be auctioned on **30.08.2024 at 10 AM** at Zonal Office in the presence of board so constituted under the chairmanship of Assistant Commissioner, City S P Zone.

Bidder should fulfill the following terms & conditions to become eligible for bidding:-

1. Bidder should be registered with concerned department of Govt. of NCT of Delhi.
2. Bidder should have turnover of minimum Rs. 1.0 Cr. in the F.Y. 2023-24.
3. Bidder should have the accounts audited for the last financial year.
4. Bidder should have atleast 2 year experience of working with Govt./PSU.
5. Bidder should not have been blacklisted/ debarred by any Govt./PSU.
6. Bidder should be in existence/ registered for last 2 years.

Bidders fulfilling the above terms & conditions should submit all relevant documents in its support along with affidavit and earnest money of Rs. 2.0 lakh before participating in the bid, which shall be refunded/ adjusted after bidding process is over. The highest bidder shall have to deposit entire amount of bid in the shape of Demand Draft immediately. The goods will be auctioned on "As is where is basis". The Chairman shall reserve the right to cancel the bids without assigning any reason for the same. The successful bidder has to remove the goods from the store within 48 hours after auction. If 30.08.2024 is declared to be holiday then auction shall be scheduled in next working day.


