1.	M/s Sudhakara Infratech Pvt Ltd - M/s Jan Adhar Sevabhavi Sanstha – M/s Balaji Industrial and Agricultural Casting Pvt. Ltd.	One of the JV members i.e. M/s Jan Adhar Sevabhavi Sanstha is registered as society in 2008 whereas the MSME registration has been done in 2021. As per tender document clause 2.2(i) only companies registered under Indian companies Act 1956/2013 or partnership firms or proprietorship firms are eligible to participate. Hence the bidder is disqualified.
