**CIRCULAR**

**Subject: Final Seniority List of Municipal Prosecutor/ Deputy Law Officer working in MCD in Level-11 of Pay Matrix as per 7<sup>th</sup> CPC (corresponding scale in PB-3 Rs.15600-39100+GP Rs.6600/- as per 6<sup>th</sup> CPC).**
