In pursuance of provisions of the Delhi Municipal Corporation (Amendment) Act, 2022, notified vide Gazette Notification No. CG-DL-E-18042022-235183 dated 18.04.2022 and in exercise of the powers conferred by Sub-section (1) of Section 3 of the DMC(Amendment) Act, 2022, the Central Government has appointed the 22<sup>nd</sup> day of May, 2022 for constitution of the Municipal Corporation of Delhi notified vide No. CG-DL-E-18052022-235827 dated 18.05.2022.

2. Further, as per Section 90A(1) of the DMC Act, on the date of establishment of Corporation under sub-section (1) of section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.
