## CIRCULAR

In pursuance of the Gazette Notification vide Notification No. CG-DL-E-18052022-235827 dated 18.05.2022 issued by Ministry of Home Affairs, Municipal Corporation of Delhi has been constituted. The relevant part of the Gazette of India Notification is reproduced below:

Consequent upon the approval of schedule of posts of Municipal Corporation of Delhi for the year 2022-2023 under section of 90 of DMC, Act vide MCD's Resolution/**Decision No. 108** dated 08.09.2022, the posts of School Inspector (General, Physical, Science & Nursery) of all streams are hereby merged and re-designated as School Inspector with immediate effect vide office order No. AO/CED/SC-IV/GF-29/2022/D-2220 dated 23.09.2022.
- 3. A provisional seniority list of School Inspector appointed/promoted on regular basis working in MCD was circulated vide circular No. AO/CED/SO-IV/2022/GF-30/2562 Dated 10.10.2022 for Objections, if any, in this regard.
- 4. In response to the provisional seniority list dated 10.10.2022, objections/representations of the applicants have been received in this office and after consideration/examination of the representations of applicants, a final seniority list of School Inspector appointed/promoted on regular basis working in MCD has been finalized without any change, is hereby circulated for information, subject to outcome of court case(s)/stay, if any.
