In exercise of the powers conferred u/s 202 (c) of the Delhi Municipal Corporation Act, 1957, the Lt. Governor Delhi hereby enhances the financial power of the Commissioner of Municipal Corporation of Delhi, from Rs 05 (five) crore to 50 (fifty) crore in the matter of entering into a contract subject to the condition that the Commissioner shall in the exercise of this enhanced power, ensure that the relevant Codal formalities are strictly adhered to and an appropriate mechanism of seeking advice of the Finance Unit of the Corporation is put in place.
