CIRCULAR

Sub: Final unified seniority list of Asstt Law Officers of Municipal Corporation of Delhi in Level 9 in the Pay Matrix as per 7th CPC appointed upto 15/7/2010

In continuation of final seniority list circulated vide No.F.6(22)/CED(II)/RPA-I/122/2006/RK/24 dated 05/04/2006, the final seniority list of Assistant Law Officer working in all the three erstwhile Corporations appointed upto 15/7/2010 was circulated by the erstwhile North DMC with the approval of the Competent Authority vide No.PA/L/North DMC/2018/2257 dated 7/12/2018.

The Delhi Municipal Corporation (Amendment) Act, 2022 passed by the Parliament and notified by Government of India vide Gazette Notification dated 18/4/2022 came into effect on 22nd May, 2022 thereby unifying the three erstwhile Corporations as the Municipal Corporation of Delhi. As per Section 90A(1) of Delhi Municipal Corporation (Amendment) Act, 2022, on the date of establishment of Corporation under sub-section (1) of Section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.

After unification of all the three Corporations with effect from 22nd May, 2022, the seniority list of Assistant Law Officer already circulated on 05/04/2006 and 07/12/2018 is required to be made combined and circulated as a final seniority list of Assistant Law Officers so that proper roster may be maintained after unification.

Accordingly, the final seniority list of Assistant Law Officers working in all the three erstwhile Corporations appointed upto 15/7/2010 is hereby circulated as final unified seniority list of Assistant Law Officers of Municipal Corporation of Delhi for information of all concerned.
