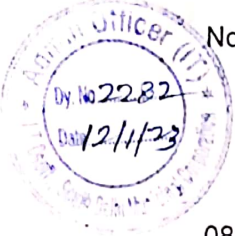

**CIRCULAR**


