**CIRCULAR**

**Sub:-Final unified seniority list of Assistant Director (P&I) in Directorate of Press & Information of Municipal Corporation of Delhi with effect from 22.05.2022 and onwards.**

In pursuance of provisions of the Delhi Municipal Corporation (Amendment) Act, 2022, notified vide Gazette Notification No. CG-DL-E- 18042022-235183 dated 18.04.2022 and in exercise of the powers conferred by Sub-section (1) of Section 3 of the DMC(Amendment) Act, 2022, the Central Government has appointed the 22nd day of May, 2022 for constitution of the Municipal Corporation of Delhi notified vide No CG-DL-E-18052022-235827 dated 18.05.2022.

2. Further, as per Section 90A(1) of the DMC Act, on the date of establishment of Corporation under sub-section (1) of section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.

3. Accordingly a unified Provisional Seniority list of Assistant Director in Directorate of Press & Information in MCD was circulated vide No. D-181/DPI/MCD/2022-23 dated 18.10.22 with prior approval of Competent Authority among all concerned for inviting suggestion/objection/comments, if any within 15 days from the date of issue of the circular. There is no objection filed by any one after lapse of considerable time. Therefore the seniority list has been finalized and is being circulated for information to all concerned.

4. This issues with the approval of the Competent Authority.


