CIRCULAR

Regulation of various activities i.e. public resort, recreation, amusement, entertainment in the form of music, singing, dancing, electronic/digital/laser show/holographic projection/virtual performance in any form or game or any other amusement, diversion or recreation or the means of carrying on the same to which the public are admitted either on payment of money or with the intention that money may be collected from those admitted in, is required.

- 2. The aforesaid activities shall be regulated by including them under Health Trade Licensing network. They will be a part of the "other" trade activities under the prevailing trade classification of entertainment and recreation which has been Notified vide Circular No.PA/MHO-I/MCD/22/97 dated 07/07/2022.
- 3. The scope of Health Trade Regulation of the aforesaid activities shall be as under:

(A) <u>Amusement activities in permanent places</u>:

Banquet halls, eating establishments, lodging/boarding establishments possessing Health Trade Licence for specific purpose of banqueting, eating/dining/lodging/boarding shall obtain separate Health Trade license u/S 422 of DMC Act, 1957 (amended to date) for performing amusement activities. They shall submit the following documents:

- (i) Site Plan of the licensed trade premises earmarked with area proposed to be used for amusement activities.
- (ii) Declaration that no extra seats will be added over and above the permitted seats.
- (iii) License period shall be for three (03) years or for a shorter duration, as per the application submitted with Municipal Corporation of Delhi.

(B) Amusement activities in temporary place :

Amusement activities in temporary places i.e. any tent, canopy, enclosures, booth or removable structure or open place i.e. any open area for performance will be regulated by furnishing/certifying the following:

- (i) Site plan of temporary or open place earmarked with area, which will be used for amusement activities.
- (ii) Availability of drinking water facility as per assembly of people.

- Availability of washroom facilities (Urinal- Male-1 per 25 or part (iii) thereof Female- nil & Latrine - Male -1 per 100 upto 400, over 400 add 1 per 250 and part thereof, Female -3 per 100 upto 200, add 2 per 100 and part thereof).
- Pest control measures ensured by possessing the certificate by (iv)authorized agency.
- Provision of solid & liquid waste management like, dustbins and/or (v) other equipment and its clearance through authorized agency.
- License for amusement activities may be obtained for duration upto (vi) one year or for short duration by payment of requisite license fee.
- In case of auditorium, if one possess Health Trade License u/S 422 of DMC Act, 1957 (amended to date) there is no need for separate Health Trade Licence for performance of amusement activities.
- Onetime Registration Fee of Rs.15,000/- and License Fee of Rs.10,000/- per Annum shall be charged for all amusement activities as per Circular No.PA/MHO-I/MCD/22/97 dated 07/07/2022.
