#### CIRCULAR

# SUB: Regarding Engagement on Compassionate Ground Basis.

The proposals for engagement of the dependent of the deceased employee, on Compassionate Ground (CG) basis are being delayed citing various shortcomings / deficiencies. The issue was reviewed by worthy Commissioner with senior officers and it has been found that files received from zones are being returned by DEMS (HQ) on one or other reason(s).

In order to avoid delay and expedite the appointment on Compassionate Ground (CG) basis, only following mandatory requirements shall be checked by DEMS (HQ) while scrutinizing such cases:-

- Prescribed/Revised Compassionate Ground (CG) Form is duly filled in and should bear signature and name with stamp of all concerned whose designation is mention thereon. (attached herewith)
- Duly attested GPF nomination form. ii)
- Duty period of the deceased employee duly verified by Accounts Department of Zone iii)
- Proof of last pay/wages drawn, duly verified by Accounts Department of Zone iv)
- Office order of  $1^{\rm st}/2^{\rm nd}$  89 days sanction and duty period of 89 days sanction duly verified by Accounts Department (if not engaged, reason thereof). V)
- Duly verified Office Order of 1st engagement if deceased was substitute/DWSK and regularization if the deceased was regular employee. vi)
- Counter sign with stamp of SI/CSI/SS on all the affidavits submitted by applicant/other family dependent members along with remarks that the language of vii) affidavit has been explained to the deponent/incumbent.
- Proper paging of file and flagging of CG form. viii)
- Certificate from concerned SS regarding all documents are placed in order for CG ix) engagement

This circular supersedes all other office orders/circular in the matter.
