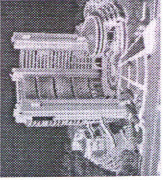

CIRCULAR

Subject:- Final unified seniority list of Medical Record Clerk (regular basis) of Municipal Corporation of Delhi with effect from 22.05.2022 onwards – Reg.

In pursuance of provisions of the Delhi Municipal Corporation (Amendment) Act, 2022, notified vide Gazette Notification No. CG-DL-E-18042022-235183 dated 18.04.2022 and in exercise of the powers conferred by Sub-section (1) of Section 3 of the DMC (Amendment) Act, 2022, the Central Government has appointed the 22nd day of May, 2022 for constitution of the Municipal Corporation of Delhi of notified vide No.CG-DL-E-18052022-235827 dated 18.05.2022.

2. Further, as per Section 90A (1) of the DMC Act, on the date of establishment of Corporation under sub-section (1) of section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.

3. Accordingly, a provisional seniority list of **Medical Record Clerk** (regular basis) working in Hospital Administration Department of unified Municipal Corporation of Delhi was issued by undersigned vide Letter No.:AO(HA)/MCD/HQ/2022/554 dated 15.11.2022 for obtaining suggestions / comments / objections to the undersigned within 21 days from the date of issue of above mentioned said letter of provisional seniority list for the post of **Medical Record Clerk** (regular basis).
