

MINUTES OF THE DEPARTMENTAL PROMOTION COMMITTEE MEETING HELD ON 15.10.2025 AT 03.00 P.M. UNDER THE CHAIRMANSHIP OF ADDL. COMMISSIONER (PH) FOR PROMOTION OF MULTI TASKING STAFF (REGULAR)/ASSTT. MALARIA INSPECTOR/MALARIA INSPECTOR (ADHOC) TO THE POSTS OF ASSISTANT MALARIA INSPECTOR & ASSTT. PUBLIC HEALTH INSPECTOR IN LEVEL- 4 (Rs.25500-81100) IN THE PAY MATRIX.

A meeting of Departmental Promotion Committee was held on 15.10.2025 at 03.00 PM for promotion of Multi Tasking Staff (Regular)/Assistant Malaria Inspector (ad hoc)/Malaria Inspector (Ad hoc) to the posts of Assistant Malaria Inspector & Asstt. Public Health Inspector on regular basis in Level- 4 (Rs.25500-81100) in the Pay Matrix. The following officers were present:-



2. The Departmental Promotion Committee (hereinafter called the Committee) was informed that after unification of erstwhile Corporations i.e. North DMC, South DMC and East DMC, the Municipal Corporation of Delhi established w.e.f. 22.05.2022 as per the notification issued by the Central Government under Section 3 of the DMC Act, 1957 (as amended by the DMC (Amendment) Act, 2022).

3. The Committee was informed that as per RRs of Asstt. Malaria Inspector & Asstt. Public Health Inspector, the method of Recruitment is as under:

4. The Committee was informed that as per Schedule of Posts, 2018-19 of erstwhile South DMC, all category of group-c posts in grade pay Rs. 1800/- i.e. cremation attendant, funeral van attendant, wood cutter, Malaria Jamadar, Malaria beldar, food hygiene beldar, sanitary guide, mate orderly, stretcher bearer and Ciass have been clubbed together as MTS (PH as per 6th CPC recommendations. The same is also continued in the Schedule of Posts, 2025-26. Accordingly, Public Health Department has issued a final seniority list for the post of Multi Tasking Staff (Public Health) vide Circular No. AC(PH)/MCD/HQ/2025/139 dated 05.05.2025



and No. AC(PH)/MCD/HQ/2025/280 dated 18.09.2025 after seeking and incorporating objections/suggestions received from the officials concerned on display the same on MCD's website and distribution of circular to DDO/DHO concerned.

5. The Committee was also informed that the incumbents who have completed the qualifying service i.e. 11 years of regular service in the grade of MTS (PH) as on 01.01.2025 and fulfills the eligibility criteria as per the Recruitment Rules of the posts of Asstt. Malaria Inspector and Asstt. Public Health Inspector are considered for promotion to the post of AMI & APHI.

6. The Committee was informed that the DDO/DHO of Zones/HQ were requested vide No. AC(PH)/MCD/HQ/2025/191 dated 03.07.2025 followed by reminders dated 15.07.2025 and dated 18.07.2025 to furnish the COP Report and Work Conduct/ ACRs reports for eligible officials as per RRs of the AMI/APHI. A certificate has also been sought from concerned DDOs that no eligible officials are left to send above said report. In response, we have received nomination of **68 officials**.

7. The Committee was informed that as per DoPT's guidelines issued vide OM No. 35034/7/97-Estt. (D) dated 08.02.2002, the benchmark for consideration of promotion of group-C official is 'good'. Further, as per para 6.2.1 © of DoPT's OM No. 22011/5/86-Estt. (D) dated 10.04.1989, where one or more CRs have not been written for any reason during the relevant period, the DPC should consider the CRs of the years preceding the period in question and if in any case even these are not available the DPC should take the CRs of the lower grade into account to complete the number of CRs required to be considered. Accordingly, the Committee has considered the CRs/APARs for the last 05 years i.e. upto 2023-24 and in case of non availability/NRC, the CRs for the previous year upto 2013-14 have been considered.

8. The Committee was informed that in the column of Integrity of some of the APARs, it is mentioned good in place of beyond doubt and it has been considered as beyond doubt by the Committee.

9. The Committee was informed that being MTS (PH) the feeder cadre post of both AMI & APHI, the officials were informed to tender their option of preference (Ist/IIInd) either AMI or APHI. In response, 12 officials have tendered their first option of preference as APHI and remaining officials have tendered their first option as AMI.

10. The Committee was informed that the officials who have completed 11 years of regular service as per RRs in the Public Health Department and having 10th qualification and Sanitary Inspector Diploma are being considered for promotion to the post of AMI & APHI.

11. The Committee was informed that as per Deptt. Of Personnel & AR OM No. 36021/7/75 Estt. (SCT) dated 25.02.1976, SC and ST Officers who are within the normal zone of consideration should be considered for promotion alongwith others and adjudged on the same basis as other and those SCs and ST amongst them who are selected on that basis may be included in the general list in addition to their being considered for separate select lists for SCs and STs respectively. Accordingly, all eligible officials have been considered against the vacancy of category 'UR'.

12. **Vacancies:** The Committee was informed that as per Schedule of Establishment 2025-26, there are 600 posts of Asstt. Malaria Inspector and 255 posts of Asstt. Public Health Inspector in MCD and out of which 180 posts fall under promotion quota of AMI and 25 posts fall under promotion quota of APHI. The vacancy details of posts fall under promotion quota of AMI & APHI is as under:

(b) Assistant Public Health Inspector:-

As per DoPT's guidelines issued vide OM 36012/17/88-Estt.(SCT), Dated 25.04.1989, reservation in posts by promotion should be made applicable to all grades or services, in which the element of direct recruitment, if any, does not exceed 75%. In the instant matter of APHI, direct recruitment quota is 90%, hence reservation is not applicable for promotion to the post of APHI.

13. **Assessment of DPC:** Having examined the RDA/COP reports and grading in the ACRs/APARs/Work & Conduct report for the relevant period, regular service and education qualifications and other provisions of RRs, vacancy position, reservation point as per roster, and the DOPT instructions/guidelines issued time-to-time in this regard, the Committee assessed the following officials for regular promotion to the post of APHI/AMI as under:
