**CIRCULAR**

**Subject: Final Seniority List of Deputy Director (Education) working in MCD in Level-12 of Pay Matrix as per 7<sup>th</sup> CPC (corresponding scale in PB-3 Rs.15600-39100+GP Rs.7600/- as per 6<sup>th</sup> CPC).**

In pursuance of the Gazette Notification vide Notification No. CG-DL-E-18052022-235827 dated 18.05.2022 issued by Ministry of Home Affairs, Municipal Corporation of Delhi has been constituted. The relevant part of the Gazette of India Notification is reproduced below:

This is in continuation of the Final Seniority List of Deputy Education Officer (renamed as Deputy Director of Education) issued vide CED Circular No. F.6 (43)/CED(II)/88/21/ 486/4806-18 dated 13.02.1989 (Sty. No. 01 to 02) and vide No. F.6(43)/CED(II)/88/67/8319-29 dated 04.05.1992 (Sty. No. 03). All the three officers namely Dr. Vijay Kalra, Smt. Indira Rani Yadav and Sh. Bhikari Dass, who were enlisted in the said final seniority list dated 13.02.1989 & 04.05.1992 have already been retired from Municipal services, hence their names are being omitted from the seniority.
