
Subject:- Final Seniority List of Executive Engineer (Civil) working in unified Municipal Corporation of Delhi (earlier known as North/South/ East DMC) in the Pay Band-3, Rs. 15600-39100 + Grade Pay Rs. 6600/- (corresponding scale in Pay Level-11 as per Pay Matrix of 7th CPC)

A Revised Final Seniority List of Executive Engineer (Civil) of General Wing of all three Corporations viz. North/South/East DMC, in the Pay Band-3, Rs.15600-39100+ Grade Pay Rs.6600/-was issued vide Circular No. F.8(38)/CED(III)/Pt.IV/2008/1887 dated 08.05.2015 for Executive Engineers (Civil) appointed upto 09.01.1997, upto Seniority No. 92. The said seniority list was issued in continuation to Final Seniority List issued vide Circular No. F.8(38)/CED(III)/ 88/37/17111-56 dated 14.07.1995.

Thereafter, in continuation of Final Seniority Last dated 08.05.2015 and in supersession of earlier Final Seniority List issued vide Circular No. F.8(38)/CED(III)/2008/RK-14/GF/40 dated 03.05.2011, another Revised Final Seniority List of Executive Engineer (Civil) was issued vide Circular No. F.8(38)/CED)/2008/Pt.V/2015/3697 dated 06.11.2015 for Executive Engineers (Civil) appointed upto vacancy year 2007-08, upto Seniority No. 134, as per recommendations of Review DPC of original DPC-2008, held in UPSC on 17-18.09.2015. The UPSC has forwarded that revised panel vide letter No. F.1/30(6)/ 2015/AP-1 dated 22.09.2015 and the same was notified vide CED's office order No. F.8(8)/CED(NDMC)/Rev.2008/2015/3522 dated 15.10.2015.

Final Seniority List dated 08.05.2015 and 06.11.2015 were issued after considering the objections received against Provisional Seniority List to the post of EE (C) issued vide Circular No. F.8(8)/CED(NDMC)/96/Pt.VII/1658 dated 23.04.2015 and F.8(38)/CED/2008/2015/3536 dated 16.10.2015 respectively. Since all the objections received against the Provisional Seniority List dated 23.04.2015 and 16.10.2015 have already been examined and considered, Final Seniority List of Executive Engineer (Civil) earlier circulated vide dated 08.05.2015 and 06.11.2015 by erstwhile North DMC are hereby re-circulated for all concerned in the capacity of Unified Municipal Corporation of Delhi as the same has come into force vide notification in Gazette of India vide dated 18.05.2022 (earlier known as North/South/East DMC), subject to outcome of the Court Case(s)/stay, pending in the various Courts and/or any other court case(s), if any.
