The recommendation of DPC held in the UPSC has been notified vide CED's office order No. F.8(9)/CED/86/2014/Pt.2/2023/G.F.-11/107 dated 11.04.2023 and F.8(9)/CED/86/2014/Pt.2/2023/G.F.-15/1117 dated 07.06.2023.

Now, therefore in continuation of Final Seniority List of Executive Engineer (Electrical) circulated vide circular dated 23.09.2003, a Fresh Provisional Seniority List of Executive Engineer (Electrical) appointed upto the vacancy year 2022 on regular basis is hereby circulated for information of the officers concerned for inviting objections. 
