- Eligibility conditions: Officer under all Organized Accounts Services/ departments 2. under the Central Government:-
 - Holding analogous posts on a regular basis in the parent cadre or department
 - (ii) With 2 years regular service in the grade rendered after appointment thereto onregular basis in Level-13A of pay matrix or equivalent in the parent cadre/department.
 - (iii) With 3 years regular service in the grade rendered after appointment thereto on regular basis in Level-13 of pay matrix or equivalent in the parent cadre/department.
