Sub:- Conduct of Election for Constitution of Town Vending Committees (TVCs).

The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014, read with the Delhi Street Vendors Rules, 2017, mandates constitution of Town Vending Committees (TVCs) in every local authority.

Each TVC shall consist of 30 members, including 12 elected vendor representatives, 6 members nominated by the local body (including Chairperson), and 12 nominated members from Police, Traffic Police, Market Associations, NGOs, Banks, RWAs, Revenue Department, etc.

As per Rule13 (2) "The Commissioner or Chairperson or Chief Executive Officer of the Local Authority shall by a notification express its intention to conduct elections for the members of a Town Vending Committee representing the street vendors of the area under the jurisdiction of the concerned Local Authority. "

As per the provisions of the Delhi Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2017, Schedule to Rule 14, Para 2, "the local authority shall, by a resolution, determine the date, time and place for conduct of elections. "

Elections shall be conducted as per the following tentative schedule:-

a.	Commencement of Nomination Filing	3 rd July 2026 (11 A.M. to 03.00 PM)
b.	Last date of Nomination	10 th July 2026
c.	Scrutiny of Nominations/Final date for objection/Display of Valid Nomination	11 th July 2026
d.	Withdrawal of nomination	Till 13 th July, 2026 (before 05:00 PM)
e.	Polling day for Election	2 nd August 2026 (08.00 A.M. to 05.00 P.M.)
f.	Counting of votes and Declaration of results	4 th August 2026 (08.00 AM onwards)

Accordingly, as per rule 14 and procedure prescribed in schedule (para2 & 3), MCD has published notification to conduct election and public notice, reservation and schedule in the leading Newspapers of Hindi English of Delhi and conduct elections at place decided by Returning officers/Chairperson of TVC.

As per section 22(2)(d) of Act the number of members representing the street vendors shall not be less than forty per cent. who shall be elected by the street vendors themselves in such manner as may be prescribed.

Provided that one-third of members representing the street vendors shall be from amongst women vendors.

Provided further that due representation shall be given to the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, minorities and persons with disabilities from amongst the members representing street vendors.

As per Rule 12 (4) "The Chairperson shall ensure that due representation is given to the Scheduled Castes/Scheduled Tribes, Other Backward Classes, Minorities and Persons with disabilities from amongst the persons representing street vendors while conducting elections to the Town Vending Committee."

In compliance with statutory mandate, the following reservation roster has been worked out for elected vendor members:

Note:- As per the Gazette notification dated 27 January 2014, the Central Government hereby notified as Minority community viz. Jain, Muslims, Christians, Sikhs, Buddhists, and Parsis.

As per section 22(1) of Act "The appropriate Government may, by rules made in this behalf, provide for the term and the manner of constituting a Town Vending Committee in each local authority: Provided that the appropriate Government may, if considers necessary, provide for constitution of more than one Town Vending Committee, or a Town Vending Committee for each zone or ward, in each local authority."

Elections are to be conducted for constituting 23 Town Vending Committees (TVCs) vide this office letter No. AC/MCD/CL&EC/2025/D-410 dated 06.11.2025 in all the 12 zones of MCD. Twelve members in each TVC shall be elected from amongst the street vendors.

For participating in the election process as per schedule, the voter shall possess/carry any one the following original documents:-

- (i.) Tehbazari License/COV issued by MCD.
- (ii.) Voter I-Card. (iii.) Aadhar Card (iv.) Driving License (v.) Passport (vi.) Passbook with Photograph issued by Bank/Post office (vii.) PAN card. (viii) Pension Document with photograph.

Keeping in view of the above, all zonal DCs being ERO cum RO are requested to take necessary action for conducting the election smoothly as per the schedule.
