Completed similar work/s means the work of Supply / Installation of Outdoor Gym / Open Gym. Necessary corrigendum in this regard has been notified.
3.	Copy of Solvency Certificate is allowed in bidding or not?	Upload copy of solvency certificate in technical Bids. It is mandatory for bidders to submit Solvency certificate for this tender in original for an equal / more amount of Rs.80.00 Lacs from a Nationalised/Scheduled bank in India. Scanned copy be uploaded with technical bid and its original must be submitted in the office of Dy. Director (Hort.) HQ-I at 16 <sup>th</sup> Floor E-1 Block S.P.M. Civic centre New Delhi-110002.
4.	How many maximum bidders will be issued Parallel Rate Contract?	Parallel Rate Contracts will be issued for Rs.200.00 Lacs to successful L-1 Bidder and Rs.150.00 lacs each Parallel Rate Contract Amount will be issued to other two bidder matching the L-1 Rates as per Section 13.2.
5.	Whether Technical Bid can be submitted manually or online?	The Technical Bids and Financial Bids must be submitted online only. However, the copy of Technical bid documents submitted online may be submitted in spiral binding at the office of DDH(HQ)-I for timely evaluation of bids.
6.	How much turnover is mandatory for this tender?	Minimum Average annual financial turnover of the bidder should be at least Rs.100.00 Lacs or more during any of previous three financial years out of the last five (05) consecutive financial years. The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheet.
