## **CORRIGENDUM-I**

Sub:- Corrigendum in respect of request for Proposal for Selection of an Agency for Collection of Parking Charges Using FASTag for four/six wheelers and UPI/NCMC/QR for two wheelers along with Operations and Management of MCD Owned Public Parking Spaces (Cluster 1 & Cluster 2). (NIT No.1729 dt. 11.10.2023)

- 1. The ECS i.e capacity of vehicles in three parking sites, viz., (i) Jagdamba Market No1 Sultanpuri (ii) Basement 1 and 2, District Centre Janakpuri and (iii) Bench and Bar Club-Opposite Old Delhi Railway Station may be read as 24 (4 W) & 21 (2 W), 88 (4W) & 122 (2W) and 100 approx. (4W) & 20 approx. (2W) respectively. The RMLF of the Clusters will remain same.
- 2. The name of the parking site at "Multi-level Car Parking- Subash Nagar" may be read as "Multi-level Car Parking- Subash Nagar, Block 6/7"
- 3. Parking rates exclusively for Munirka Multilevel Parking site are as under:

Type of Vehicles	Applicable fee for multilevel parking	Cost of monthly pass for multilevel	Concessional monthly fee for multilevel parking only for original resident of Munirka
CAR	Rs. 20/- per hour subject to a maximum of Rs. 100/- per day	Rs. 2000/- per vehicle	Rs. 1100/- per vehicle
2 Wheeler	Rs. 10/- per hour subject to a maximum of Rs. 50/- per day	Rs. 1000/- per vehicle	Rs. 750/- per vehicle
Commercial Vehicles (tempos small carriers)	Rs. 50/- per hour subject to a maximum of Rs. 250/- per day	Rs. 3000/- per vehicle	No Concession.

- Note 1: There are no parking maps of the parking sites at Munirka (Multilevel), Multi Level Car Parking -Subhash Nagar, Bock- 6/7 and Bench and Bar Club - Opposite Old Delhi Railway Station.
- Note 2: The ECS of the parking site at Bench and Bar Club Opposite Old Delhi Railway Station is approximate and it may increase or decrease as per the actual space. MLF will be accordingly fixed on prorate basis.
- Note 3: The revised map of the parking site at Sapna Cinema, East of Kailash is attached with this
