With reference to the pre-bid queries received from the prospective bidders, reply of the Department is as under:-

S1. No.	Query of Advertiser	Reply of Department
1.	In the earlier tender NIT No.CO(Advt)/E-Tender-02/2023-24/MCD/NIT/D-46 dated 10.04.2023, as per the NIT Cluster No.7 Mahipalpur Bye Pass Road Connection NH-8 to Mahipalpur Red Light to Ryan Public School Red Light (Both Side of Road, Najafgarh Zone. As per the last corrigendum for above NIT (Copy attached) you mentioned that the Unipoles/Structure will be installed 30 mtr away from NH-8/Mehrauli-Mahipalpur Road.	In this regard, it is informed that this condition is already specified in the tender document. Please see page-30 of e-tender-09/D-556 dated 07.06.2023.
2.	Whereas the Ryan Public School is situated on same stretch and had one Unipole just near the red light of Ryan Public School now please clarify that is there any Unipole existing.	It is that in the past a Unipole site was awarded near Ryan Public School vide allotment letter dated 01.07.2013 and contract was concluded on13.10.2016. Thereafter, no unipole has been there since the end of said contract. This status prevails today.
3.	Please clarify that Mehruali - Mahipalpur Road is a part of the aforesaid mentioned cluster or not.	It is clarified that this Cluster starts from 30 meters away from NH-8 to Red Light Ryan Public School and from Ryan Public School Red Light to 30 meters away from NH-8, Najafgarh Zone.
4.	Some of the Unipoles have been indentified to be installed alongside National Highway NH-44. In the previous tender, Unipoles	"As per RFP".

	along the National Highway could not be installed, as there was no permission from NHAI. In case some understanding for installing Unipoles has been arrived at by MCD, documents of the same may please shared with them for active participation in the E-tender.	
5.	The incubation of 15 days is far too short for installation of new Unipoles, and incubation period minimum 30 days should be given.	"As per RFP".
